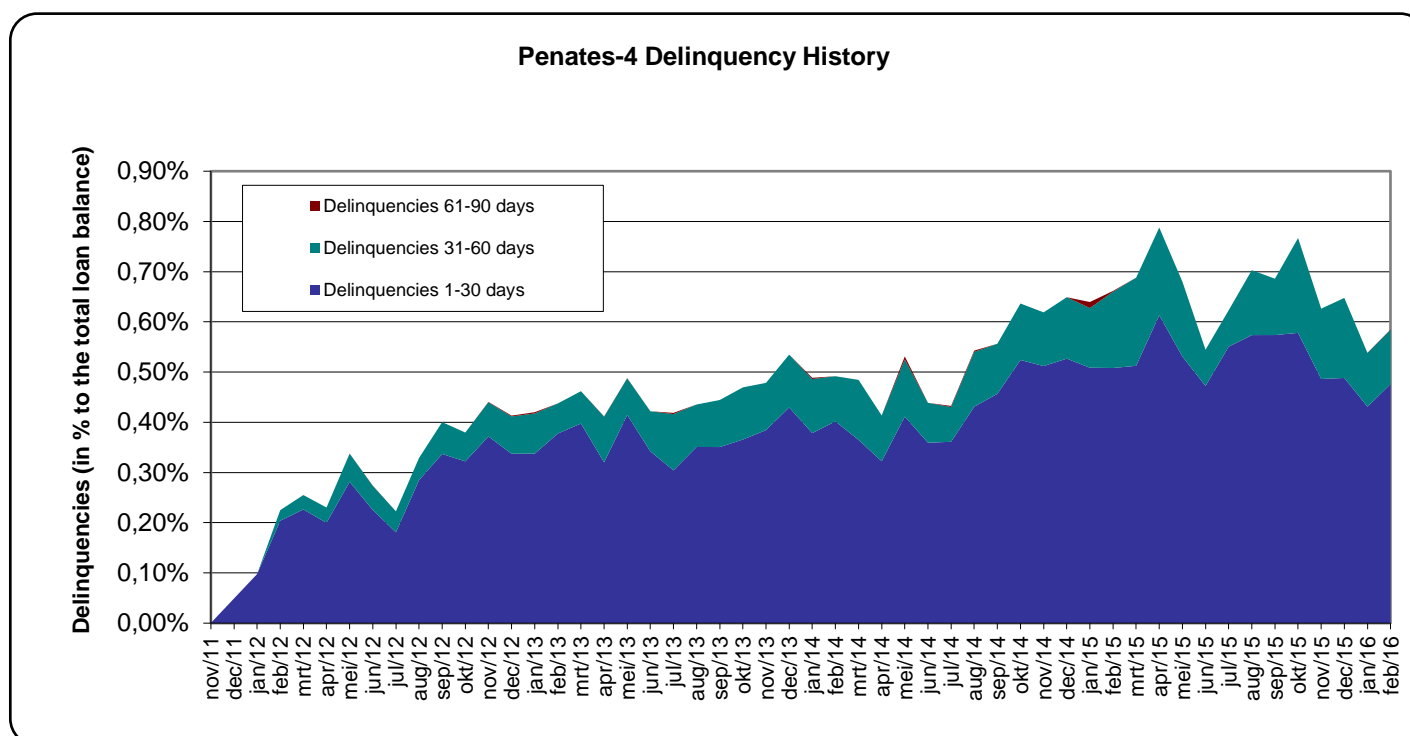

Historical Delinquency Data



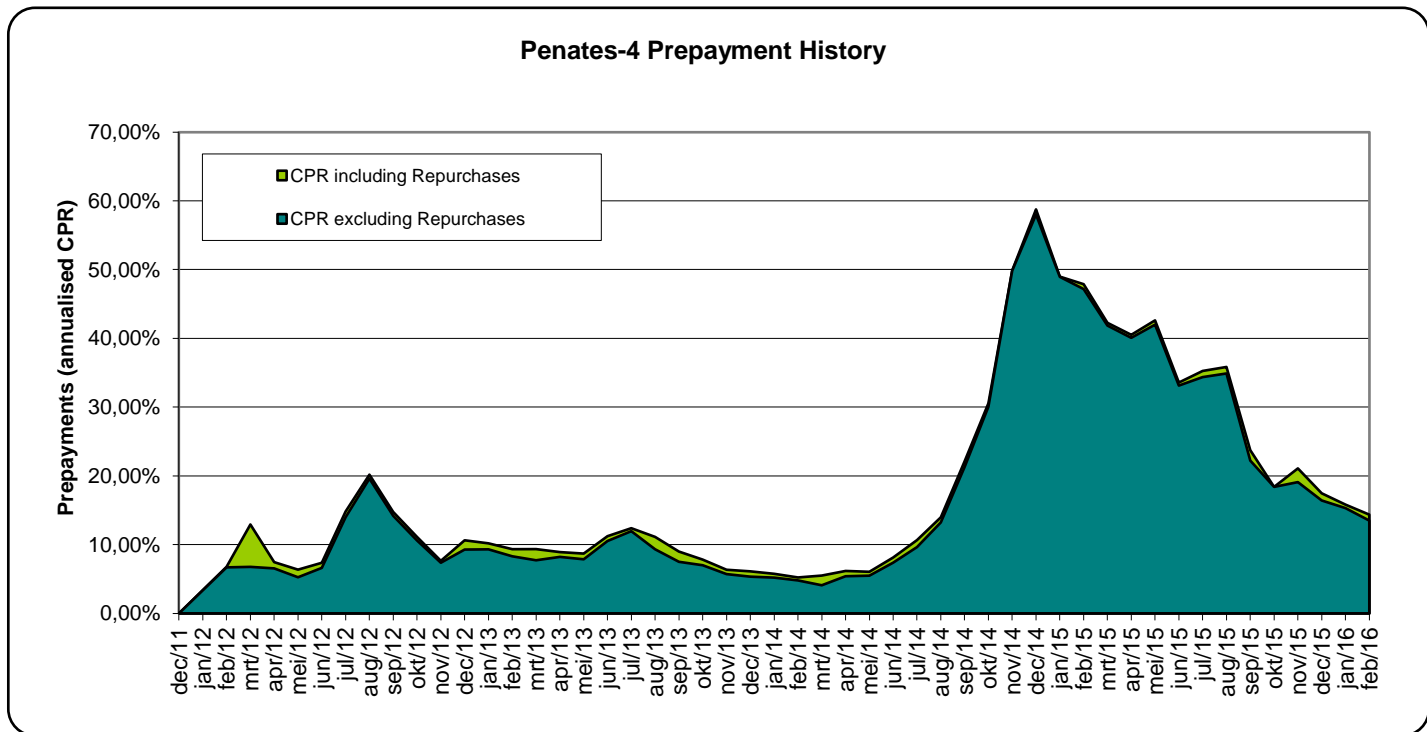
