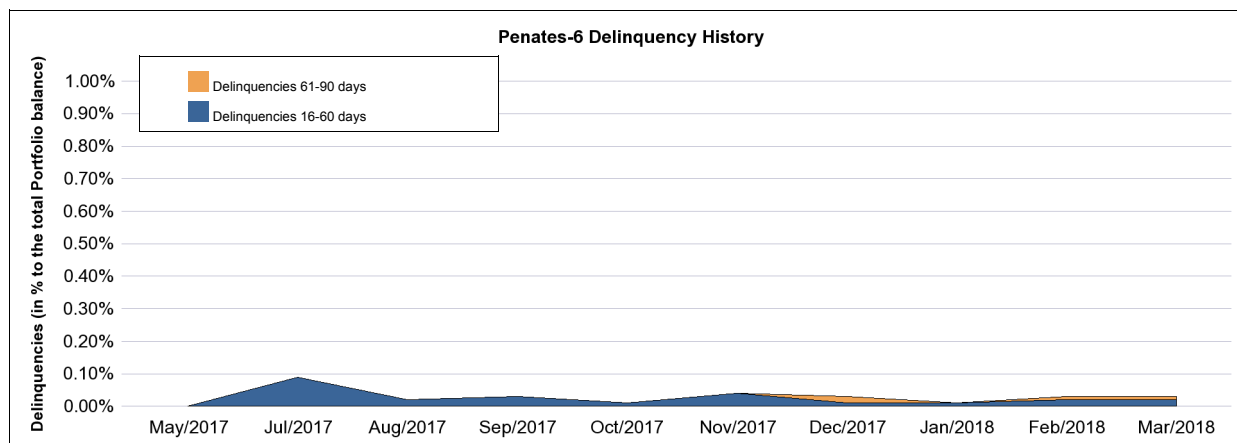

3.6. Historical Delinquency Status



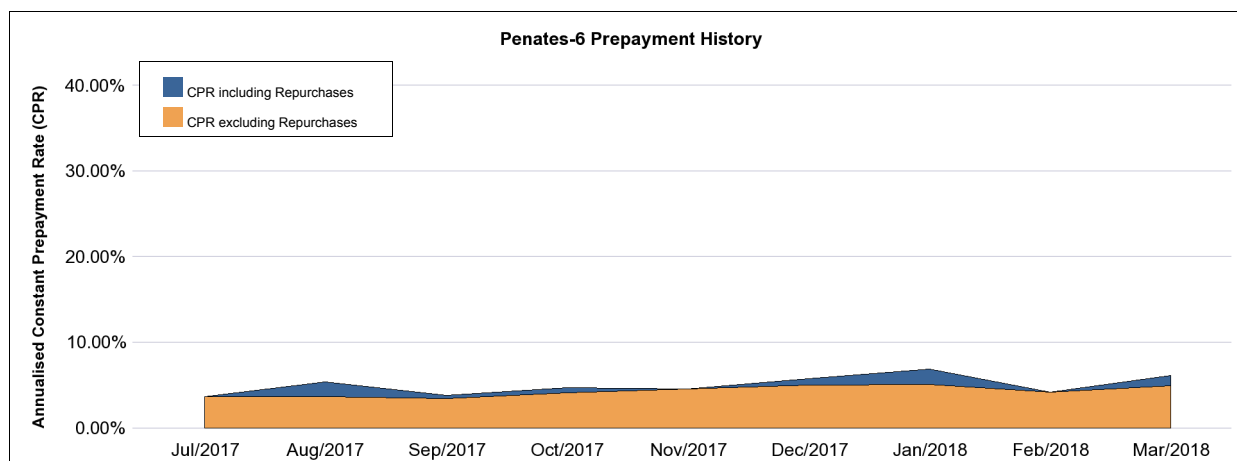
